V. APPROVAL OF MINUTES



VI. PROCLAMATION

Keith Higgins came before the commissioners to ask to enter a proclamation to recognize and declare the week of April 24-30, 2022, as Appling County Crime Victim's Rights Week. Higgins then read the proclamation. Also, he invited the Commissioners and everyone in attendance to the Crime Victims Memorial April 27th at the Sheriff Complex at 6 P.M.

VII, PRENSENTATION

Dr. Scarlet Miles Copeland presented a PowerPoint on E-SPLOST VI. E-SPLOST will be voted on May 24, 2022. E-SPLOST is the fairest tax, everyone in our county and surrounding counties pay this penny and it's not a new tax. E-SPLOST money is used to reduce the mileage rate as well as spend on projects for Appling County Board of Education. It runs for five years and one penny. The presentation had the future projects for E-SPLOST VI and the past projects for E-SPLOST V.

VIII. PUBLIC INPUT

There was no public input at this time.

IX. OLD BUSINESS

A. Board of Health Appointment-

Hayden Rozier said last meeting we tabled the Board of Health Appointment, and that Lynn Johnson is still willing to serve. Commissioner Harris said he spoke with Mrs. Johnson and made the motion to reappoint Lynn Johnson on the Board of Health. Commissioner Edwards made the second.

The motion carried unanimously.

B. Seven Rivers Board Appointment-

Rozier stated that this Appointment got tabled last meeting and Commissioner Harris had a nomination of Charles Davis.

Commissioner Harris made the motion to nominate Charles Davis to the Seven River Board Appointment and Commissioner Wilkerson made the second.

The motion carried unanimously.

X. NEW BUSINESS

A. T-Ball Restroom Facility Award at Complex

Hayden Rozier had three bids for the T-Ball Restrooms Facility at the Complex. The following bids was J.M. Miles for \$87,891.00, Dixie Builders for \$77,150.00, and Altamaha Builders for \$123,300.00. Rozier recommended going with the low bidder Dixie Builder for \$77.150.00. All contractors met all the requirements and attended the mandatory pre-bid meeting.

Commissioner Harris made the motion to accept the low bid from Dixie Builders, Commissioner Edwards made the second.

The motion carried unanimously.

B. Head Start Facility Update

Rozier gave the update that the Commissioners voted in the past to add on to the existing Head Start facility, and they solicited for a Community Development Block Grant for \$170,000 towards the \$750,000 project. The architect that was hired has retired and is no longer in business. Rozier spoke with Hugh Darley with Heart of Georgia and tried to go back and utilize the second bidder. The timetable has expired, and we must start back over and request RFQ/Request for Qualifications to start the process back over and will be about a year and a half to two years out. Rozier is asking for permission to solicit RFQ's with the Heart of Georgia.

Commissioner Boatright made the motion for permission to solicit RFQ's for the Head Start Block Grant. Commissioner Wilkerson made the second.

XI. SHERIFF'S REPORT

Mark Melton gave an update on Dusty Davis as the newest Deputy, he just finished the Police Academy. He is the 13th employee that Sheriff Melton has sent through the Academy, 11 have successfully completed the Academy. One employee is currently in the academy and two employees will be attending the July class. Melton still has a shortage in the school resource officers, patrol, and investigators. Friday April 1, 2022, they had a law enforcement expo, and it was a great success. They had about 1100-1200 people and students that came through the gates. Fifty-four agencies and vendors showed up, it was the 4th year that the expo was held and the largest they have ever had. The Ag Center was an asset for this event. The Department had a free air search today at the High School and was really pleased with the results of the search with minimal issues found.

XII. RECREATION DEPT REPORT

Wilton McCall was present to give an update on the Summer Recreation Events that has started. We have completed our T-ball, Baseball, and Softball sign ups. The games have started on March 29, they play on Mondays, Tuesdays, Thursdays, and Fridays starting at 5 o'clock and McCall invites everyone out to watch some ball games. The Rec Dept is having a Local Track meet on Thursday April 7th at the high school track, they have approximately 200 participants in track. First and second place winners will advance to District on April 16th in Camden County. Then first, second, and third place winners from District will advance to State on May 6-7th in Jefferson, GA. The total participation of coaches, participants, and volunteers is 737. The update on the new pool is 75 percent complete. The pool is completed, they are working on the enclosure. The pool should be completed the last of April or the first of May.

XIII. ROADS & BRIDGES

Brooks Johnson was present to give an update on the Road Department on the previous month. They have had a problem with people stealing stop signs. They have had 147 beaver tails turned in since the last meeting. Old Field Cemetery was closed overnight in March, and this was believed to caused by beavers as well. Johnson gave an update on rocks, the price on rock is going up and it's becoming almost impossible to get due to labor shortage. Also, we had a windstorm in March on Saturday with 40+ MPH wind gust the same weekend as Peaches to Beaches. Johnson thanked all the employees for their help.

EXECUTIVE SESSION

There was no Executive Session at this meeting.

COUNTY MANAGER'S REPORT

Rozier gave an update on the Landfill, the EPD Inspection and scored 95 out of 100. Also, he read two Thank you notes for the new Recreation Football Fields, one was from the Middle School Girls Soccer Team and the other was from the Middle School Football team and Boys Soccer team. There is a Ribbon Cutting this Thursday April 7th at 5 P.M. at the Library and Rozier invited the Commissioners to attend. On April 13, 2022, there will be a Called Meeting at 10 A.M.

Chairman Shumans thanked everyone for attending the meeting. Shumans announced that The Heritage Center and Appling First are sponsoring a Candidate Form April 26, at the Commissioners Meeting Room.
