

ADVERTISEMENT FOR BIDS

Sealed bids will be received for the Northside Park – Splashpad, at the Appling County Board of Commissioners, 69 Tippins Street, Baxley, Georgia 31513 until June 23, 2026 at 2:00 P.M. (Local Time), at which time they will be publicly opened and read.

The work under this Contract will consist generally of the following:

The construction of the North Side Park Splashpad including +/- 2,250 SF splashpad, site grading, 4” sidewalk concrete, fencing, concrete decking, demolition of existing pool, grading, grassing and other erosion control measures as shown on the plans as all necessary items to properly construct the park.

All work on the Project must be completed within 150 consecutive calendar days of date of notice to proceed.

Bid shall be submitted on Bid Proposal Forms furnished for that purpose, in accordance with the Contract Documents and the Specifications, which are on file and may be reviewed (by appointment only) at the office of Hofstadter and Associates, Inc., Consulting Engineers, 4571 Arkwright Road, Macon, Georgia 31210.

No bid will be considered unless sealed and filed with Appling County prior to the time set forth above, and accompanied by a Bidder's Bond, payable to Appling County, for 10 percent of the amount of the bid; to be forfeited as liquidated damages in the event that the bid be accepted and the bidder fail to enter promptly into a written contract and furnish the required Payment Bond and Performance Bond and Insurance Certificates. Bids arriving after the designated time will be returned unopened.

No bids shall be withdrawn for a period of 60 days after the opening of bids. Appling County reserves the right to reject any or all bids and to overlook and/or disregard informalities or irregularities in the proposals.
